# **CORRECTIONS DEPARTMENT**

A. Request for the authorization to pay overtime to FLSA exempt employees in the classification of Psychological Associate II, class code 50382, who are required to work overtime at Kilby CF, Tutwiler PFW, Tutwiler QIF, and Draper QIF to move inmates from county jails into the Department of Corrections. Due to COVID-19, Corrections utilized a cohort-based intake system which limited the number of new intakes. Given the availability of the COVID-19 vaccine, the Department is now increasing the intake sites to move inmates in at a faster rate. These employees will be eligible for straight time for hours physically worked over 40 in a workweek. Overtime is requested from April 16, 2021, through September 30, 2021, and should not exceed \$55,000.00.

B. Request for the authorization to pay overtime to FLSA non-exempt employees who are required to work overtime at Kilby CF, Tutwiler PFW, Tutwiler QIF, and Draper QIF to move inmates from county jails into the Department of Corrections. Due to COVID-19, Corrections utilized a cohort-based intake system which limited the number of new intakes. Given the availability of the COVID-19 vaccine, the Department is now increasing the intake sites to move inmates in at a faster rate. Overtime is requested from April 16, 2021, through September 30, 2021, and should not exceed \$295,000.00. Classes involved in this overtime are listed below:
